### INFO- RULES OF REGULATIONS

- **Food vendors are by invitation only so we may provide event attendees with a variety of food selections without duplication.**
- Booth space must be paid either prior to the event or during the event. The Executive Director will collect funds on event night.
- Space numbers will be assigned & painted on curb & layout map will be posted on the MSVB office door on the day of the event.
- Booth Spaces are 10 X 10. You must provide your own tables, chairs, & electrical cords and duct tape.
- Electricity is mostly 20Amp/110v service with very limited access to 30Amp/220v service.
- Generators must be quiet and placed stratgically to avoid the noise and fumes interfering with attendees or other vendors.
- For insurance purposes, a copy of your food license or your FEID# must accompany this application before you may vend.
- No hawking is allowed in the street by the city ordinance. Sell behind table only.
- No beverages of any kind are permitted for sale or to be given away.
- Only the items you list below may be sold. Any new items you wish to sell must be requested in writing beforehand for approval by MSVB.
- Set up begins at 4:00 PM & booths must be ready to open by 5:30 PM. Booths may not be broken down until close of event at 9:00 PM.
- Failure to show up more than 3 times during the year, without prior notification, will result in elimination from all future MSVB events.
- In the event of inclement weather, the event will be cancelled by 3:00 PM and announced on radio, social media, & Facebook.
- Booth fees will not be refunded or reapplied to another event if you are unable to participate or due to cancellation by MSVB for any reason.
